- vi. that the warranties and representations above are and shall remain valid and in full force throughout and after this grant.
- 3. WARRANTIES, REPRESENTATIVES AND COVENANTS OF THE DONEE

  - i. To pay all tax, rates and government tenements to government or other regulatory agency over the demise property from the commencement of this deed of gift.
  - ii. To assume the full ownership over the property and retain the exclusive right to transfer, assign, donate or sell the property subject to the provisions of Land Use Act or other government regulations.
